CONDITIONS OF ENTRY TO STICKER VINTAGE RALLY & COUNTRY FAYRE	
1	Traders must be covered by a valid Public Liability (PL) insurance policy. A copy of which MUST be submitted with this application form.
2	Owners must ensure drivers are fully competent and have a valid and appropriate licence and be qualified to drive any vehicles brought on any part of the Rally Site.
3	Users of bottled gas or electricity must provide a Fire Risk Assessment.
4	The MAXIMUM speed of 5MPH shall apply to all moving vehicles on any part of the Rally Site. Any trader found to be exceeding the speed limit will be asked to leave forthwith.
5	All owners and drivers must obey the Marshal's instructions and not inconvenience or endanger any persons or animals on any part of the Rally Site.
6	Owners are responsible for their own personal and trade possessions for which the organizers will take no responsibility.
7	All visitors to the Sticker Vintage Rally & Country Fayre must adhere to the Chairmans Health and Safety Policy which will be displayed on the site and/or provided directly to traders (specific parts).

ADMINISTRATION AND SAFETY
Set Up: Stands can be set up between 1200-1830hrs on Friday 31st July 2026 or by 0930hrs on each day of the Rally. Stands are expected to be open until approximately 1700hrs on the Saturday and 1600hrs on the Sunday. Stands will be in the area of the football field, access via the main Sticker AFC gate or located in the Rally Field, access through gate on St Stephens Road. Stand positions will be allocated in the preceding week of the Rally with site location maps of stands emailed to Traders and displayed at the site to guide traders. Cancellation by the Rally Committee: In the event of the cancellation, postponement or abandonment of the Rally, the Rally Committee will make refunds at its discretion. Traders will not have any claim against the Rally Committee or any member of the Committee in respect of any loss or damage whatsoever consequent upon the Rally, or any part of it, failing to be held or having to be abandoned, for whatever reason. Trade Waste: Please note that there are no facilities for the disposal of trade waste from the Rally Site, all stall holders must make their own provisions for the disposal of their waste. Camping/Caravan access is from 1200hrs Friday 31st July 2026 to pre-booked applicants only. Camping/Caravaners must remove their own waste. All wastewater must be collected in a suitable container for disposal and not be allowed to run over the ground. Chemical toilets and wastewater must be disposed of in the facilities provided for this purpose in the Display Field. Portaloo toilets and tap drinking water will be available in the Display field and Rally field. Users of generators must have an appropriate fire extinguisher and fire blanket. In dry conditions barbeques may be banned. They are not to be used after 2100hrs. Liquefied petroleum gas containers must be stored in an upright position away from any source of heat. Firefighting equipment will be available in all event fields at the marked fire points.
